Re: 3rd Grant – The Désiré Collen Stichting ("DCS") for the renovation of "Huyze Prof. Dr. Marc Verstraete"

Dear Sirs.

It is our pleasure to inform you that we, as the current Trustee of the Collen Charitable Trust (CCT) (the 'Trustees' (which expression includes the trustees for the time being of the Collen Charitable Trust)) have approved an additional 3rd grant in the amount of EUR 1,000,000 (one million EURO) (the '3rd Grant') to DCS, a private not for profit foundation under Belgian law (constitution articles enclosed as attachment 1) for the renovation up to standard for not for profit academic and social use (within the limits of the mission of the CCT) of the former residence of Prof. Dr. Marc Verstraete (the "Project"). This residence, located 29 Minderbroedersstraat, 3000 Leuven, Belgium was acquired by DCS for 850,000 Euro, which were entirely contributed by funds of former graduates/collaborators of Prof. Verstraete at KULeuven. The renovated property will be named "Huyze Prof. Dr. Marc Verstraete".

The 3rd Grant is conditional upon the following terms and conditions:

1. Purpose

The 3rd Grant will only be used for the renovation of the residence at 29 Minderbroedersstraat, 3000 Leuven, Belgium.

2. Payment

The 3rd Grant will be transferred to the designated DCS bank account with BNP Paribas Fortis (IBAN; BE25 0018 8774 4682; BIC: GEBABEBB) before 30 June 2024.

3. Evaluation and Reporting

3.1 DCS shall report to the Trustees in respect of the renovation works and after their completion.

- 3.2 Each written report must be signed by an appropriate officer of DCS, be furnished to the Trustees, and contain two parts:
 - a. Narrative Account: The narrative account should provide an assurance that the activities under the 3rd Grant have been conducted in conformity with these terms.
 - b. Financial Account: The financial account, prepared in Euro, should be provided.

4. Record Maintenance and Inspection

DCS shall procure that the Trustees are given sufficient access so as to enable their representatives to monitor and conduct an evaluation of operations under this 3rd Grant, which may include a visit at reasonable times by personnel of the Trustees to observe the Project, discuss the Project with relevant personnel and review financial and other records and materials connected with the activities financed by the 3rd Grant.

5. Publicity

- 5.1 The 3rd Grant to DCS shall be named 'Collen Charitable Trust 3rd Grant for Huyze Prof. Dr. Marc Verstraete'.
- 5.2 DCS shall not issue any public statement, press release or other publicity which refers to the Collen Charitable Trust or the 3rd Grant other than in a form approved by the Trustees in writing.

6. Liability

The Trustees shall have no responsibility in administering the 3rd Grant or directly oversecing the Project and shall have no liability to any person engaged in the delivery of the Project, in respect of any aspect of the Project. DCS agrees to indemnify the Trustees against all liabilities, reasonable costs and expenses, damages and losses suffered or incurred by the Trustees arising out of or in connection with any breach by DCS of any law, regulation or obligation in respect of the delivery of the Project.

7. Misuse

If any portion of the 3rd Grant is used for a purpose other than the Project, the Trustees shall be entitled at their discretion to require repayment of that part of the 3rd Grant which has been misused. Any potential future income of the Project in DCS will be reinvested in the Project or in not for profit activities of DCS with similar goals.

8. Severance

If any provision of the agreement contained in this letter shall be found by any court or administrative body of competent jurisdiction to be invalid or unenforceable, such invalidity or unenforceability shall not affect the other provisions of this letter, which shall remain in full force and effect.



Governing Law and Jurisdiction
 The agreement contained in this letter is governed by, and shall be construed in accordance with, the laws of the Bahamas and the parties submit to the exclusive jurisdiction of the courts of the Bahamas.
